**OBSERVERS REPORTS****SCHOOLS** - Alyssa Knobel

On December 17, 2007, the North Shore School District Board of Education adopted a plan to place incoming military dependents' children at Red Oak, Wayne Thomas and Oak Terrace elementary schools, Edgewood Middle School and Northwood Junior High. Now in its second year of implementation, the district administration has undertaken a plan assessment and review (PAR) of the implementation.

The PAR report, originally scheduled to be presented to the Board of Education in February 2010, has been rescheduled to **March 16** due to the press of other issues, including contract negotiations, budgetary issues and the district's strategic planning initiative. The rescheduling will allow for a more thorough review and analysis of the PAR report's data and its impact on the district's schools.

**PARK DISTRICT** – Peggy Malecki

Remember our beaches and ravines study many years ago? Finally...Illinois Department of Natural Resources (IDNR) Open Space and Lands Acquisition and Development (OSLAD) Program has awarded a grant of \$400,000 to the Park District of Highland Park. The grant will help enhance recreational facilities and provide ravine and bluff improvements at Rosewood Beach. The plan is to build a new pavilion with restrooms, showers, changing areas and a food concession. Access to the beach will be improved by reconstructing the 1930s ravine trail, and degraded shoreline areas will be improved.

This data is used to distribute congressional seats and to distribute federal funds to local, state and tribal governments for community services, education, road rehabilitation, public transportation and more.

**Help us Reform Illinois Redistricting****Join our petition drive to put the Fair Map Amendment on the November Ballot**

Here is another state-wide league effort. LWVIL is asking us to help get 500,000 signatures by April 1, which will place an amendment to the Constitution on the November ballot. We all know legislative districts are now not the most fair and equitable, drawn behind closed doors to ensure the reelection of the favored and the elimination of those who may have incurred displeasure. This amendment would create an independent commission to draw a map with compact and equitable boundaries, all under the public eye.

It's so easy to take petitions to your bridge and book clubs, cocktail parties, anywhere friends gather. Signers must be registered voters. And they're just signing to allow the amendment on the ballot, not for or against it.

**The problem under the existing process:**

- Illinois legislators create their own legislative districts behind closed doors.
- Either the Democrats or the Republicans gain full control by a hat drawing.
- Districts are drawn to protect incumbents of the winning party.

**The solution which the Fair Map Amendment offers:**

- Legislative districts would be drawn by an independent commission.
- Maps would be drawn in an open and transparent process, with public input.
- Specific criteria would be used to make the process fairer to all.

**What you can do to support the Fair Map Amendment:**

- Sign the petition to put the amendment on the November ballot.
- Gain more signatures by circulating a petition. Download petitions and instructions. <http://www.ilfairmap.com/> and tell others about the Fair Map Amendment.

## LWV LAKE COUNTY - PRIMARY EVENTS

In January 2010, the League of Women Voters of Lake County hosted three successful candidate forums covering 6 races at 3 levels of government (federal, state and county) with a variety of co-sponsoring organizations. The locations also were varied: Grayslake, Vernon Hills, and North Chicago. Our adaptability keeps our League members busy!

On Sunday, January, 10, we, the Daily Herald, and Grayslake Community High School District 127 hosted a forum for candidates running for the 8th Congressional District and for the 62nd State Representative. All 6 Republican candidates in the 8<sup>th</sup> participated. For the 62nd State Representative race, both Republican candidates, Sandy Cole, incumbent, and Paul Mitchell, attended. The Social Studies teachers and Grayslake High School administrators were excited about this learning experience for their Advanced Placement Government and Honors students. Four students acted as co-moderators with Joan Kaltsas (LWV-LFLB). Many students volunteered to make this a very successful forum. The auditorium was filled with students, parents, teachers, and residents.

On Sunday, Jan. 17, the League and co-sponsor the Daily Herald held a forum at the Laschen Community Center in Vernon Hills. A welcome statement was given by Pete Nenni, Lake County Editor of the Daily Herald. All candidates for 59th District State Representative were in attendance. Once again, Joan Kaltsas (LF-LB) moderated.

The Honorable Margaret Mullen gave a brief presentation on the courts in Lake County and qualities to consider when voting for judges. Six candidates for judgeships each gave a brief statement on his/her qualifications and why they were seeking the office. Republican candidates for the Appellate Court, Second District were Ann B. Jorgensen and Mary S. Schostak. Democratic candidates for 19th Circuit, 4th Subcircuit candidates were Mark Levitt, Christopher M. Kennedy, Jeremy Cowen Schwartz and Dwayne Douglas.

The Village of Vernon Hills videotaped the forum and showed the program until Election Day on its public access channel. Buffalo Grove, Lincolnshire, and Lake Forest also showed the program on their public access channels.

On Sunday Jan. 24, the third forum was held at the Greenbelt Cultural Center in North Chicago. The races were for the 60th State Representative and Lake County Sheriff. The League had worked previously with the NAACP and Waukegan Leadership Council and asked both organizations to co-sponsor this forum. There were no Republicans on the ballot. John Kremptotic and Douglas Roberts, candidates for Lake County Sheriff, attended. The winner in the primary will run against Mark Curran, Republican incumbent, in the general election in November.

Judy Hoffman, (LWV-EV) not only moderated the forum, but also made brief presentations about the Census Complete Count and the Fair Map Amendment petition. As the State League had clarified its position regarding the Fair Map redistricting petitions, LWV-LC volunteers were able to gather signatures at the forum.

We are looking forward to the fall!
